WHAT'S NEW IN 2026

1. Participants are asked to respectfully consider the issue of cultural appropriation when selecting repertoire. To assist with understanding cultural appropriation, the following definition is provided as a guide.

"Cultural appropriation applies when cultural borrowings or adaptations from a minoritized culture reflect, reinforce, or amplify inequalities, stereotypes, and historically exploitative relationships that have direct negative consequences on equity-seeking communities." [Canada Council Website]

2. Addition of a clarifying statement to the preliminary text for Class 1200 Piano Solo

One or more movements of a concerto at the comparable concert level are permitted in junior, intermediate, and advanced classes.

3. Addition of a clarifying statement to the text for Class 1400 Classical Guitar Solo

Piano accompaniment is permitted, when applicable if indicated in the score.

- 4. Addition of clarifying statements to the preliminary text for Class 1800 Musical Theatre Solo
 - Spoken passages are allowed only if published in the original script/score. The text must be supplied to the adjudicator
 if the submitted score only indicates cues for the text.
 - All selections are to be from a staged musical, sung from a published score, and in the published key.
 - Junior and Intermediate competitors may transpose to a different key as long as they indicate the performance key
 on the submitted score.
 - Competitors may perform in a base costume and use costume enhancements [e.g., hat, scarf, jacket, shawl] and one
 hand prop per selection. Full costume changes between selections, including layering of costumes, are not
 permitted.
- 5. Addition of clarifying text in the Chamber Ensemble Section

The majority of members in a chamber group must be in the class's listed age bracket. *If there is no majority, then the average age of the members is used.*

- 6. Addition of clarifying text in the Composition Section
 - The composition recommended from the Local Festival **must** be submitted. The title may be altered if the original title is indicated in brackets. The composition may incorporate suggestions received from the local festival adjudicator.

IMPORTANT!

Local festival administrators should advise teachers and students to check the local, provincial, and national syllabi carefully when choosing music for festival entries. Administrators should also ensure their adjudicators are aware of class requirements when recommending students to the Local Stream Qualifying Round of competition.

2026 FCMF LOCAL STREAM QUALIFYING ROUND SYLLABUS

Local Stream Qualifying Round for Territories, Western Provinces, and Ontario June 11-16, 2026 | Entry Deadline: June 2, 2026

Students recommended from affiliated local festivals in the Western Provinces and Ontario can seek a recommendation to the FCMF National Music Festival through the FCMF Local Stream Qualifying Round. The requirements for this virtual qualifying process are the same as for the provincial festivals, as outlined in this syllabus.

The Local Stream Qualifying Round is a virtual competition for recommended students or ensembles from Local Festivals affiliated with FCMF through the Local Association Membership Class to seek recommendations for the FCMF National Music Festival.

The Federation of Canadian Music Festivals Board of Directors governs the Local Stream Qualifying Round. It is administered by FCMF staff and/or volunteers.

Participants at the FCMF National Music Festival will represent the Local Stream Qualifying Round, not their province. Recognition of the local festival will be consistent with those of provincial associations.

ELIGIBILITY

Local festivals affiliated with FCMF through the Local Association Membership Class may determine who represents them at the Local Stream Qualifying Round [LSQR] in one of two ways:

- 1. The Local Festival can add the LSQR classes to their syllabus, and students or ensembles enter those classes if they are interested in being eligible for the LSQR. The local adjudicator would determine which student[s] or ensemble[s] should represent the festival in each class.
- 2. The local festival adjudicator could choose a student[s] or ensemble[s] from the appropriate grade and/or age levels for each class, making sure they have the eligible repertoire to meet the requirements of the class for which they are being recommended.

A sufficiently high standard of performance is required at the local festival for a recommendation to the [LSQR].

To be eligible to advance to the FCMF National Music Festival from LSQR, the competitor[s] must be residing in Canada or studying in Canada.

A local festival may send **TWO** competitors in each of the LSQR Developing Artist Stream, Emerging Artist Stream, Ensemble Stream, and Composition Stream classes.

Local Festival adjudicators may recommend **TWO** competitors in each Non-Competitive Education Stream class **directly** to the FCMF National Music Festival.

Local festivals are encouraged to have their adjudicator name one or more alternate competitors and complete the necessary

paperwork, in case the first-choice competitors are unable to participate for any reason.

In disciplines with age requirements, the competitor's age will be determined as of December 31 before the LSQR. Local festivals must obtain proof of age if requested.

Participation is limited to non-professional musicians. A non-professional musician is defined as a person whose principal means of livelihood is not obtained from the performance of music in the category in which they are competing. This stipulation does not, however, preclude such a person from having occasionally received remuneration for musical services rendered, even in the area in which he or she is competing.

Competitors may only be recommended to the LSQR from ONE local festival per discipline. Each competitor must accept or decline a recommendation from a local festival within 48 hours.

The designated entry fee is <u>non-refundable</u> unless FCMF declines the entry. Once an entry has been accepted, no changes to the repertoire will be allowed unless required by the national office.

Alternates

Adjudicators may recommend alternates in any class if the standard of performance is met. If a registered competitor is unable to participate, the named alternate can replace the competitor. As much notice as possible should be given to the alternate and the FCMF office.

Entry fees are non-refundable unless an alternate has been named and registered. The original entry fee, less a \$25 administration fee, will be reimbursed to the originally registered participant. The alternate will be required to pay the entry fee in full prior to participation.

For Chamber ensembles, if a recommended competitor from the Local Festival level is unable to participate at the LSQR level, they can be replaced by an alternate. There is a maximum of one substitution permitted for each Chamber group.

REPERTOIRE

Participants are asked to consider the issue of cultural appropriation respectfully when choosing selections: "Cultural appropriation applies when cultural borrowings or adaptations from a minoritized culture reflect, reinforce, or amplify inequalities, stereotypes, and historically exploitative relationships that have direct negative consequences on equity-seeking communities."

The **minimum** repertoire requirements to be performed at the LSQR, as outlined in the LSQR Syllabus, **MUST** have been heard by the recommending adjudicator at the Local Festival. This may be in a specifically designated LSQR/National Class or through a combination of performances in classes at the Local Festival. Competitors may add additional movements of their multi-movement works, and/or additional selections within the maximum time.

A Concerto or Concerted Work is defined as any composition written for a solo instrument with orchestral accompaniment.

Sonatinas, Sonatas, and Concertos can be from any music time period, as per syllabus requirements. A one-movement Sonatina or Sonata meets the requirements for Junior and Intermediate levels.

A selection is a composition or song cycle meant to be one body of work, as the composer indicates. Competitors may perform partial or complete works based on syllabus requirements and time restrictions. A second selection cannot be another movement or song from the same work.

In disciplines with graded repertoire requirements, competitors must indicate on their entry form the syllabus from which they determined the level of difficulty of their repertoire. Syllabi accepted as references for the LSQR are the Royal Conservatory of Music [RCM], Conservatory Canada [CC], or any other recognized national or regional conservatory syllabi.

To encourage the use of new music and preserve objectivity, we will also accept grading letters from the Royal Conservatory

of Music or another recognized national or regional conservatory.

Local festival adjudicators will be responsible for determining if ungraded works fall within the parameters of the class requirements. All other technical questions, such as whether a musical is from a staged musical, memorization, appropriateness of spoken introductions, overall suitability of selections for the student, artistic interpretation, etc., would remain at the discretion of the national adjudicators.

Competitors are allowed to make brief introductory remarks for some or all of their selections performed in competition, if desired. Introductory remarks are included in their overall performance time.

RECORDING AND PERFORMANCE REGULATIONS - ALL CLASSES IN THE LSQR ARE VIRTUAL

Professional recordings are not required for the competition, but good audio and visual quality are very important. The quality on most cell phones is adequate.

- 1. Video recording can be done in a home, studio, or other location
 - Must include a clear picture of the student performing, showing face or facial profile, hands [in the case of
 pianist and instrumentalist], and instrument. A view of the full stage is required for Musical Theatre
 recordings.
 - One-take recording
 - Editing or splicing in any form is strictly prohibited
 - Camera angle must remain consistent throughout the performance
 - The complete performance of all pieces should be performed consecutively on one video without stopping the camera during breaks. Please be aware of the time limits.
- 2. A video file is uploaded to a private YouTube channel as an 'unlisted' video. These videos can only be viewed by someone with the link.
- 3. A PDF file of the score for each selection performed is to be named with the same naming convention:

 Discipline_Level_LocalFestival_ClassNumber_CompetitorName_Selection_Composer and uploaded to Google Drive.

 *Example: Piano Junior Moncton 202 JaneSmith Prelude No. 6 JohannSebastianBach
 - The PDF must include the cover and/or title page of the book if the selection comes from a book, and all pages of music performed in the competition
 - Submitted scores MUST contain clear measure numbering.
 - If the selection score is a digital download, the receipt for digital purchase or proof of Public Domain must be included in the PDF file.
 - All copyrights must be observed.
 - Junior and Intermediate competitors must submit original solo scores of music.
 - Advanced competitors must submit an original score containing both solo and accompaniment.
- 4. Recorded entries must be submitted online on or before the June 2 deadline and must include:
 - The recording for the complete performance named as outlined in #2 above
 - A clear, scanned copy of each score as outlined in #3 above
 - A headshot photo of the competitor submitted as a JPEG or PNG file

Competitors playing with a score in Woodwind, Brass, Percussion, and Chamber classes must perform from original scores. Memorization of String sonatas is not required. Memorization requirements are listed in class descriptions. <u>Failure to play from memory in required classes will result in disqualification.</u>

In Junior and Intermediate classes, transposition is permitted, unless otherwise noted, but the performance key must be indicated on the submitted score. In Advanced classes, the submitted score must be in the performance key.

The accompanist must have an original score on the stage. Accompanists are permitted to use digital scores on tablet computers such as iPads, provided they can clearly show upon registration that copyright laws have been observed.

<u>Time limits</u> for classes listed in the syllabus must be adhered to. Timing shall be from the first word or note to the last word or note, including pauses between pieces and costume changes. <u>Performances exceeding the time limit will be disqualified</u>. Overtime performances will not be interrupted, and official timekeepers will provide no warnings or signals.

Competitors disqualified from the competition for any reason, including but not limited to playing with music, use of photocopied music, or being over time, will:

- 1. Be disqualified from award placement, even if they are the lone competitor in a class.
- 2. Be disqualified from receiving award monies.
- 3. Be disqualified from advancing to the FCMF National Music Festival in the current year.
- 4. Receive their adjudication comments and Participation Certificate.

Competitors are:

- Strongly encouraged to attend all events, such as competitor orientation and adjudication workshop/masterclass,
 if offered
- Allowed the number of performance minutes outlined in their class description. Exceeding the time limit will result in disqualification. The performance time begins with the first note/word and ends with the last note/word.
- Advised to reflect a variety of styles and periods in their choice of repertoire. They are also encouraged to use compositions by Canadian and Indigenous composers in their performances.

FCMF NATIONAL MUSIC FESTIVAL

Competitors entering classes eligible for advancement to the FCMF National Music Festival are STRONGLY encouraged to read the FCMF National Music Festival Syllabus to guide their selection of repertoire at the Local Festival and LSQR. https://www.fcmf.org/syllabus/

The FCMF National Music Festival is open to *non-professional musicians who are:

- i. Eligible according to the class description
- ii. Stated ages as of December 31 preceding the festival
- iii. Canadian citizens, or
- iv. Living or studying in Canada, who perform at festivals affiliated with Local and Provincial Music Festival Associations

*A non-professional musician is defined as a person whose principal means of livelihood is not obtained from the performance of music in the particular category in which they are competing. This stipulation does not, however, preclude such a person from having occasionally received remuneration for musical services rendered, even in the area in which they are competing. The competitor's signature is required on a national entry form confirming non-professional status. It is recommended that Local Festivals also have competitors verify, by signature, their non-professional status.

Competitors recommended by the LSQR adjudicators to the FCMF National Music Festival will have 48 hours to accept or decline the recommendation.

Competitors advancing to the National Music Festival from the LSQR must be residing or studying in Canada.

CLASS LS100 - VOCAL SOLO

- Repertoire in the Vocal discipline may not include selections from the Musical Theatre repertoire
- Voice type must be stated on the entry form, ie, soprano, alto, tenor, bass, etc.
- Performance time is from the first note or word to the last note or word, including breaks
- Selections* recommended from the Local Festival must be performed see the chart below for the required number
 of selections for each stream
- The inclusion of compositions by Canadian and Indigenous composers is encouraged
- Memorization is required.

- Selections* recommended from the Local Festival **MUST** be performed see the chart below for the required number of selections for each stream
- One or more movements of a concerto, comparable to that stream's grading, are permitted in all piano classes.
- Performance time is from the first note or word to the last note or word, including breaks
- The inclusion of compositions by Canadian and Indigenous composers is encouraged
- Memorization is required

- Performance time is from the first note or word to the last note or word, including breaks
- The inclusion of compositions by Canadian and Indigenous composers is encouraged
- Memorization is required except for Sonata selections

MUSICAL THEATRE REGULATIONS

Voice type must be stated on the entry form, i.e. soprano, alto, tenor, bass, etc.

Accompaniment shall be restricted to one piano. The piano must be respected as an instrument and may not be used as a prop and/or table. Competitors may place one hand on the piano. Similarly, the pianist is an accompanist and not a stage character.

Performance time is from the first note or word to the last note or word, including breaks

Repertoire

- Selections* recommended from the Local Festival **MUST** be performed see the chart below for the required number of selections for each stream
- All selections must be sung from a published score, in any published key of a staged musical
- Selections NOT permitted at any level include:
 - Selections from cabaret/revues [e.g., "Taylor, the Latte Boy", "Alto's Lament", "The Girl in 14G", "Darryl is a Boy", etc.]
 - o Selections from Operetta [e.g., Gilbert & Sullivan, Hebert, Romberg, Johann Strauss, Lehar, Offenbach, etc.]
 - Selections that are primarily patter [e.g., "Over the Moon" from Rent, "Rock Island" from The Music Man,
 "My Shot" from Hamilton]
- All selections are to be from a staged musical, sung from a published score, and in the submitted key.
- Junior and Intermediate-level participants may transpose to a different key as long as they indicate the performance key on the submitted score.
- A variety of vocal techniques appropriate for musical theatre may be utilized
- All selections should be age-appropriate
- Spoken passages are allowed only if published in the script/score provided
- The inclusion of compositions by Canadian and Indigenous composers is encouraged
- Memorization is required

Brief Definitions

- Musical a group of pieces connected by a storyline and characters
- Staged musical written with the intent to be performed on stage, with a set, costumes, etc.
- Non-staged musical written for movies only
- Revue a group of pieces in musical theatre style without the connecting storyline, although there may be a common theme
- Character piece a piece in musical theatre style that is not part of a show and is sometimes known as a 'standalone piece'
- Operetta falls somewhere between an opera and a musical. Like a musical, it most often contains spoken dialogue as well as song; tends to be shorter and less complex than traditional operas.
- Ballad used to describe music with a slower tempo, often of a serious or introspective nature, e.g. "On My Own" [from Les Misérables].
- Up-Tempo used to describe music with a lively tempo, often comedy, e.g. "One Hundred Easy Ways" [from Wonderful Town].

Scores

- All selections are to be sung from a published score, in any published key, of a staged musical
- The original copy can be the Broadway score, from an Anthology, or purchased online. Proof of purchase must be shown for all online purchases

Costumes and Props

- A table, chair, and coat rack may be used and will not count as props.
- Stage technicians may assist competitors with stage set-up and takedown.
- Competitors may perform in a base costume and use costume enhancements [e.g., hat, scarf, jacket, shawl] and one
 hand prop per selection. Full costume changes between selections, including layering of costumes, are not
 permitted.
- Competitors may leave the stage briefly for a drink of water or to facilitate an entrance but must not leave the stage for complete costume changes. The recording must not be paused.
- Performance time is from the first note or word to the last note or word. Breaks between selections, costume enhancements, and set-up and takedown of props are part of the competitor's total time allotment.
- Limited movement is permitted.

PROCESS

The competition is conducted at three progressive levels:

Local Festival

Adjudicators at the Local Festival may choose, in each of the Choral or Ensemble categories, **TWO** ensembles that are deemed to be of National standard. The competition is based on the performance of **TWO CONTRASTING SELECTIONS**, only **ONE** of which may include brief solo or solo ensemble passages. A signed recommendation, along with recordings and a digital copy of the music scores, must be submitted to the LSQR Administrator.

Local Stream Qualifying Round

Ensembles submitting recordings to the LSQR level of competition must perform the same selections that the adjudicator at the Local level recommended. Adjudicators at the LSQR level may choose, in each category submitted, **TWO** ensembles that are deemed to be of a national standard.

The adjudicator for the LSQR is allowed to send **two extra** ensembles, chosen from across the classes within each section [choral, chamber ensembles, bands, orchestras], with no more than one extra submission per class.

National Festival

Ensembles submitting recordings to the National level of competition must perform the same selections on which the adjudicator at the Local and LSQR levels recommended them. Performances are adjudicated, and the participants are notified.

ADJUDICATORS

FCMF engages nationally and/or internationally known musicians to adjudicate the National Music Festival.

CONCEPT

The National Music Festival is the culmination of many months of musical activity, encompassing learning, performing, and competition. A high standard of music performance is expected at each level – Local Festival, Local Stream Qualifying Round, and National Festival.

LOCAL STREAM QUALIFYING ROUND / NATIONAL CHORAL REGULATIONS

CHORAL CLASS REGULATIONS

These rules apply to all classes: Participation is limited to amateur Canadian choirs, performing in the appropriate class[es] at affiliated festivals.

- 1. A choir may enter only one choral class between #9102 and #9113 at the National level. They may enter Class #9101 [Glee/Show/Musical Group] as well.
- 2. Only selections performed, adjudicated, and recommended from Local and LSQR/Provincial Festivals are acceptable.
- 3. The competition is based on the performance of **TWO CONTRASTING SELECTIONS**, only **ONE** of which may include brief solo or solo ensemble passages. Please note that the definition of the term 'selection' for choral classes is "one piece of music by a composer and not two or more short pieces from a collection, cycle, or larger work".
- 4. In classes 9102-9113, the total number of bars of the solo or solo ensemble passage[s] must not exceed 10% of the total length of the selection. In class 9101 [Glee/Show/Musical Group], the total number of bars of the solo or solo ensemble passage[s] must not exceed 20% of the total length of the selection.
- 5. The inclusion of compositions by Canadian and Indigenous composers is encouraged.
- 6. These classes are open to equal and/or mixed voices.
- 7. Ages are determined as of December 31 preceding the festival.

CHORAL RECORDING REGULATIONS

- 1. Only audio recordings are acceptable formats for the submission of choral entries in classes #LS9102-LS9113.
- 2. Class LS9101 [Glee Choir] requires a video recording submitted by a link to an 'unlisted video'.
- 3. Recordings must be completed with the same choir, conductor, accompanist, and accompaniment as in the **original local performance**. The recording must be one take.
- 4. No acoustic or electronic compensation, filtering, or other enhancement is to be used while [or post] recording.
- 5. Recordings and music scores should contain no reference to the name of the choir, its conductor, or the festival from which it has been sent.
- 6. All copyrights regarding music must be observed.
- 7. Recorded Choral entries must submit links to the required files during the online registration process, and payment of the \$100 Entry Fee, on or before the June 2 entry deadline:
 - A link to the recordings for each selection in Google Drive
 - A clear, scanned copy of each score [including a picture of the cover if applicable, a receipt for digital purchase, or proof of Public Domain]
 - Submitted scores MUST contain clear measure numbering.
 - A short biography of the ensemble or choir and group photo.
- 8. A \$10 surcharge may be levied for each score that is submitted without numbering, proof of purchase or public domain, or proper access to the Google Drive link.

GLEE/SHOW/MUSICAL THEATRE GROUP

Class LS9101

- This class is open to school and community choirs, and ensembles [a minimum of 6 singers]
- Any combination of ages and voices
- Both selections must contain staging and/or choreography
- Time Limit: 20 minutes
- Video recording with audio

LOCAL STREAM QUALIFYING ROUND / NATIONAL INSTRUMENTAL ENSEMBLE REGULATIONS

INSTRUMENTAL ENSEMBLE CLASS REGULATIONS

These rules apply to all classes:

- 1. Participation is limited to amateur Canadian ensembles, performing in the appropriate class[es] at affiliated festivals.
- 2. Ensembles may enter only one ensemble class at the National level.
- 3. Only selections performed, adjudicated, and recommended from Local and LSQR/Provincial Festivals are acceptable.
- 4. Please note that the definition of the term 'selection' for ensemble classes is "a single movement composition OR one or more movements of a multi-movement composition". A group of pieces by the same composer or from an existing collection by a composer is acceptable as a multi-movement work.
- 5. The competition is based on the performance of TWO CONTRASTING SELECTIONS, only ONE of which may include brief solo or solo ensemble passages. Multi-movements of one piece will be counted as one selection.
- 6. For all classes, except jazz band classes #9302 and #9304, only ONE of the selections may include brief solo or solo ensemble passages. The total number of bars of the solo or solo ensemble passage[s] must not exceed 10% of the total length of the selection.

- 7. For jazz band classes, it is strongly encouraged that jazz ensembles include a minimum of one improvised solo in at least one of the two required selections. The 10% total length of solo passages does not apply to jazz band classes #9302 and #9304.
- 8. The inclusion of compositions by Canadian and Indigenous composers is encouraged.

INSTRUMENTAL ENSEMBLE RECORDING REGULATIONS

- 1. A link to **two audio** recordings, each of a single selection, is required for the submission of all band and orchestra entries
- 2. A link to **two video** recordings, each of a single selection, is required for the submission of chamber ensemble entries.
- 3. Recordings must be completed with the same group and conductor as in the **original local performance**. The recording must be one take.
- 4. No acoustic or electronic compensation, filtering, or other enhancement is to be used while [or post] recording.
- 5. Recordings and music scores should contain no reference to the name of the group, its conductor, or the festival from which it has been sent.
- 6. All copyrights regarding music must be observed.
- 7. Recorded Instrumental Ensemble entries must be submitted by placing links to the following files during the online registration process, and payment of the applicable Entry Fee, on or before the **June 2** entry deadline:
 - A link to the audio recording for each selection in Google Drive
 - A clear, scanned copy of each score [including a picture of the cover, the receipt for digital purchase, or proof of Public Domain]
 - Submitted scores MUST contain clear measure numbering
 - A short biography of the group and a group photo.
- 8. A \$10 surcharge may be levied for each score that is submitted without numbering, proof of purchase or public domain, or proper access to the Google Drive link.

CLASS LS9200 - CHAMBER ENSEMBLE

- A combination of any recognized orchestral instruments, including harp, guitar, recorder, and/or percussion, with or without piano and/or one voice, with a minimum of 3 to a maximum of 9 performers each having their own part, with no conductor.
- The majority of members in a chamber group must reside or study in the province they represent.
- The majority of members in a chamber group must be in the listed age bracket for the class. If there is no majority, then the average age of the members is used.
- Only one substitution is permitted for a Chamber Group with the approval of the FCMF Officers.
- When a piano is included, the piano part must be original and not an orchestral reduction.
- Instrumentation and amplification may be used only as indicated in the original score.
- Repetition of music is not allowed for chamber ensembles returning to the National Music Festival when more than one member returns.
- Entry Fee includes written comments and an adjudication workshop.
- Submitted scores MUST contain clear measure numbering.
- A \$10 surcharge may be levied for each score that is submitted without numbering, proof of purchase or public domain, or proper access to the Google Drive link.

COMPOSITION STREAM

The FCMF Local Stream Qualifying Round [LSQR] provides an opportunity for the following types of composition:

Solo/Duo – a composition written for one or two instruments or voices. An accompaniment is permitted. Please indicate instrument[s] on your score.

Ensemble – a composition written for any combination of three or more instruments and/or voices, including orchestral and choral scores. Please indicate instruments/voices on your score.

LOCAL STREAM QUALIFYING ROUND / NATIONAL COMPOSITION CLASS REGULATIONS

- 1. Composition classes are non-competitive. The entry fee includes an adjudication workshop. Participants will receive a certificate with a platinum, gold, silver, or bronze ribbon indicating the standard achieved.
- 2. Participation is limited to unpublished works by non-professional composers.
- 3. This is a recorded stream of classes. Each entry will consist of a printed score [PDF] and a digital recording [live or midi] of the composition [MP3 or MP4], submitted electronically. The performance does not have to be by the composer.
- 4. Each entry is assumed to be the original work of the individual whose name appears on the entry form attached to the manuscript. Any infraction of this regulation would result in the disqualification of the entry.
- 5. The composer will retain all rights to the original work; however, by entering the class, the participant agrees that the composition may be published, recorded, and available to be downloaded for public use from the FCMF websites, or employed by FCMF for publicity purposes after consultation with and agreement of the composer.
- 6. Manuscripts printed by computers are encouraged, but handwritten manuscripts are accepted. All manuscripts should be neat and legibly written in black ink, in regulation manuscript size, including all necessary details of dynamics, editing, and tempo. Please retain the original copy of your submitted work.
- 7. Submitted scores MUST contain clear measure numbering.
- 8. The maximum length of a composition in all classes is a performance time of 10 minutes.
- 9. All entries must include a Title Page, including the name of the selection and instrumentation, and a short section of programme notes or notes to the performer.
- 10. The composition recommended by the Local Festival must be submitted. The title may be altered if the original title is indicated in brackets. The composition may incorporate suggestions received from the local or provincial festival adjudicators.
- 11. Please indicate instrument[s] on your score.
- 12. The \$100 entry fee includes written comments and a workshop with the adjudicator.
- 13. A \$10 surcharge may be levied for each score that is submitted without numbering or proper access to the Google Drive link.

PROCESS

The Composition Stream is conducted at three progressive levels:

Local Festival

Adjudicators at the Local Festival may choose, in each Composition class, **two** entries that are deemed to be of National standard. The submitted entry must be one original composition. The signed recommendation, along with the recording and a digital copy of the music score, must be submitted to the LSQR Administrator.

Local Stream Qualifying Round

Entries recommended to the LSQR level must be the same original composition that the adjudicator at the Local level recommended. Compositions are adjudicated. Participants receive adjudication comments and participate in a workshop.

Adjudicators at the LSQR level may choose, in each class, **two** compositions that are deemed to be of a national standard. The composition adjudicator for the LSQR is allowed to send **two extra** submissions, chosen from across the classes, with no more than one extra submission per class.

National Festival

Entries recommended to the National level must be the same original composition that the adjudicator at the LSQR levels recommended. Compositions are adjudicated. Participants receive adjudication comments and participate in a workshop. They will receive a certificate with a seal indicating the standard of performance achieved.

ADJUDICATORS

FCMF engages nationally and/or internationally known composers to adjudicate the National Music Festival.

CONCEPT

The National Music Festival is the culmination of many months of musical activity, encompassing learning, performing, and competition. A high standard of music performance is expected at each level – Local Festival, Local Stream Qualifying Round, and National Festival.
